THESE SERVICES INCLUDE CASE MANAGEMENT, WORKFORCE DEVELOPMENT, CHILDCARE, AFTERSCHOOL PROGRAMMING, HOUSING SERVICES, AND HEALTHCARE. IN FISCAL YEAR 20-21, UMOM'S FAMILY SHELTER PROGRAMS SERVED OVER 818 HOUSEHOLDS WITH CHILDREN TOTALING MORE THAN 2,927 INDIVIDUALS.
